

## **European Union REACH, RoHS POPs Statement**

KONG certifies, to the best of its knowledge, that all laser products listed below conform to the following REACH, RoHS and POPs Directives and Amendments.

## **RoHS Chemicals List**

As noted, the Directive requires that each separate *homogenous* part of the component not contain more than the specified concentrations for the below 10 substances:

The term homogenous refers to meeting the concentration of each restricted material and being below the specified threshold for each component capable of being physically separated.

RoHS Restricted Substances	Limit
Cadmium (Cd)	0.01% (100 ppm)
Lead (Pb)	0.1% (1000 ppm)
Mercury (Hg)	0.1% (1000 ppm)
Hexavalent chromium (Cr6+)	0.1% (1000 ppm)
Polybrominated biphenyls (PBB)	0.1% (1000 ppm)
Polybrominated diphenyl ether (PBDE)	0.1% (1000 ppm)
Bis(2-ethylhexyl) phthalate (DEHP)	0.1% (1000 ppm)
Butyl benzyl phthalate (BBP)	0.1% (1000 ppm)
Dibutyl phthalate (DBP)	0.1% (1000 ppm)
Diisobutyl phthalate (DIBP)	0.1% (1000 ppm)



For these purposes REACH, RoHS and POPs compliant means that:

- 1. REACH compliant means that the above listed products are categorized as articles under the REACH Regulations and as such do not contain more than 0.1% by weight per article of substances listed in the latest Candidate Substances of Very High Concern (SVHC) list as of 241 Substances, the latest released by the European Chemicals Agency.
- 2. Products do not contain any of the substances above the maximum limits under the given application in Annex XVII of the EU REACH Regulation.
- 3. None of the components that make up the finished article contain more than the above listed limit by weight per article of any of the listed substances based on both the REACH and RoHS Directives.
- 4. Our suppliers have confirmed the compliance status of the relevant products to us.
- 5. We have implemented processes to confirm suppliers' statements and maintain relevant documents to support it.
- 6. Third-party testing is conducted to confirm ongoing compliance.
- 7. KONG Company does not intentionally add hazardous substances to the finished goods.

Our statements regarding REACH, RoHS and POPs compliance do not extend to, or apply to any product subjected to unintended contamination, misuse, neglect, or accident.

We work with our suppliers to ensure accurate data for all products. As such, we will continue to identify any potential use of materials as specified in the REACH, RoHS and POPs Directives and confirm the representation made in this compliance statement remains accurate. To that end, we reserve the right to amend this statement at any time based on subsequent developments or information.
